- The Data Endorsement Ad-Hoc Committee has now met a total of 8 times since its first meeting in February 2025. The committee has established a first draft of a framework for the endorsement process - defining the key criteria, questions, considerations, etc. which will help to determine which datasets receive GAC endorsement.

Next Activities / Tasks

- Test the draft process with a few examples of actual datasets, identify any needed changes, and continue refining the process. May potentially have a recommendation for the GAC to review at the December meeting.

Emergency Preparedness Committee

Responsible Priority Projects and Initiatives

- Critical Infrastructure Data Workflow
- U.S. National Grid Materials

Most Recent Successes

- Full Committee/Leadership Team
 - Continue efforts to cleanup committee's files and bring efficiency to its IT infrastructure to facilitate handoff. File review underway with handoff to start during first week of September and complete by September 27.
- Critical Infrastructure Assessment (CIA) Project Team
 - Document a long-term workflow to keep fire, law enforcement verified annually by MN counties. In work.
 - Coordinate with the Data Endorsement Workgroup to develop procedures for "endorsing" critical infrastructure data sets. In work.
 - Before end of FY 26:
 - Resolve discrepancies between critical infrastructure data sets posted to the MnGeo critical infrastructure data page and those found on MnSAV. Pending
 - Document a long-term workflow
- US National Grid Materials
 - USNG Store will go live September 15. New USNG Center is currently being developed. USNG Institute website is considered functionally complete.
 - Develop documentation for USNG map production - developing documentation

Next Activities / Tasks

- Chair Swazee is stepping down as committee chair and Britta Maddox will assume this role.
- Continue working on 2026/27 workplan goals.
- Cory Richter is currently researching the viability of using members of the EPC's Minnesota Geospatial Community Resilience Volunteer group to: 1.) Create a better-defined program of self-study for those interested in getting more involved in the use of GIS within the Emergency Service Sector, and 2.) Create a way for EMs without GIS support to use these members as volunteers projects.
- Underground Utilities Mapping (UUM) Project Team:
 - FuzionView will go live in Minnesota's 811 system in mid-September with Open Source release scheduled for December 2025. Before the end of FY 26, prepare to close project and transition to an industry hosted effort which will steer any future development.
- Geospatial Assistance (GA) Project Team (Activated CY 2025): Geospatial Assistance Workgroup
 - Due to the lack of available volunteers, and in coordination with the Project Team Chair, this project team has been terminated. There are no further activities planned.

Barriers

- Lack of dedicated funding needed to support efficient management of basic EPC operations. Payment for web hosting, website, Zoom, and other critical administrative services as currently being provided by SharedGeo will terminate effective September 30th.

- As has been previously reported over the past decade, Chair Swazee firmly believes the extent of EPC activities clearly demonstrates the need for at least one, preferably two, dedicated, full-time, support employees assigned to MnGeo. This concept was previously discussed during creation of legislation which brought into existence the MGAC and MnGeo. It is believed the return on investment through use of GIS as a force multiplier in the Emergency Service Sector to save lives and reduce suffering in Minnesota would far exceed the additional expenditure required to create the position(s). A draft document supporting this concept was submitted to the state GIO in June, 2024.

- In the week of August 25th, the GAC hub build team completed the second round of revision requests from Megan S and Sally W. MnGeo will review GAC home hub and three committee hubs (Outreach, CAN DO and Data Endorsement) and work with MNIT Communications for an overall branding approval. This will be followed by a review and approval from the GAC.
- A Community Mapping Expo outreach event was held on August 13th at LOGIS. This year's theme is "Helping Communities Thrive with GIS – Nonprofit and Government Collaboration." We had 30 registrants from nonprofit, 39 from the government sector and 11 from the education domain. On event day, we had 50 in-person participants and 25 online attendees. Presenters included the State GIO and GIS professionals from Esri, Minnesota Design Center, Trust of Public Land and LOGIS. Event highlights and photos can be found in this [story map](#).

Next Activities / Tasks

- After the first four ArcGIS Hubs are approved, GAC hub build team will move on to build the next four committee hubs.
- With new leadership, Open Data Subcommittee will continue to work on the following.
 - Parcels - Encourage counties to contribute more parcel attributes
 - Parcels – Explore how the Department of Revenue's PRISM data could be used to enhance existing parcel data
 - Opt-In - Continue to contact counties about opt-in
 - Open Data – How to address counties concerned with becoming an open data county

Additional Priority Projects and Initiatives Updates

- The Open Data Subcommittee meets every 6 weeks to discuss status and strategy of encouraging counties to opt-in to sharing data toward statewide composites.
- Statewide Opt-in Composite datasets are available on the MN Geospatial Commons.

- Of 87 MN counties, 55 contributed parcels, 46 have agreed to contribute address points and emergency service zones, and 45 have agreed to contribute road centerlines to date.
- Parcels, address points, and road centerlines are available for download on the MN Geospatial Commons. The data is being refreshed on a quarterly basis.
- The Outreach Committee convenes on the first Tuesday of every month to monitor GAC Committee Hub sites build progress and the Outreach Committee's community engagement activities and communication endeavors.

 - The main goal of publishing this new dataset was to have just one county dataset on the commons
- Reviewed Cadastral Point Data Standard (CPDS) with PLRC and Arrowhead Regional Collaborative. Submitted the standard to the GAC Standards committee for Public review
